Authorities to Issue Certificates of Origin

Dear All Business communities,

Addressing the issue regarding Indonesia Certificate of Origin (CO) Issuance and also the Indonesia Authorized CO Issuance Body, Directorate of Export and Import Facilitation, Directorate General of Foreign Trade, Ministry of Trade would like to inform the followings:

- Based on Indonesia Presidential Decree No. 58 of year 1971 on Determination of the Authorized Officials to Issue CO, President of the Republic of Indonesia appointed Minister of Trade or officials designated by him as the competent officials and authorities for issuing the CO for Indonesia export goods;
- 2. Based on the Minister of Trade Regulation No. 28/M-DAG/PER/4/2016 regarding the Amendment to the Minister of Trade Regulation No. 32/M-DAG/PER/5/2015 on the institutions to issue the CO and Minister of Trade Decision No.666/M-DAG/KEP/6/2016 regarding the Amendment to the Minister of Trade Decision No.727/M-DAG/KEP/6/2015 on the Determination of the institutions to issue the CO, Ministry of Trade of the Republic of Indonesia appointed 86 authorized Regional Issuing Authorities to issue CO in Indonesia (please find the enclosed list);
- 3. Kindly be advised that Indonesia Chamber of Commerce is not an authorized agency to issue CO in Indonesia;
- 4. Kindly be informed that from the past practice there were numbers of the CO issued by the Indonesia Chamber of Commerce that caused significant problems of customs clearance and CO verification cases raised by The Customs of export destination countries, especially for preferential CO.

Taking into consideration the above said issues, we strongly suggest if your importers request for a CO issued by the Indonesia Chamber of Commerce, the exporters are expected to provide an explanation and clarification to the importer regarding institutions entitled and authorized to issue CO in Indonesia there are only 86 Regional Issuing Authorities that has been appointed by the Minister of Trade and not including Indonesia Chamber of Commerce.
