- 1) Ministry of Trade has delegated 86 Regional Issuing Authorities in Indonesia as the appointed Authorized Institutions to issue COO in Indonesia that is stipulated in the Minister of Trade Regulation No. 60/M-DAG/PER/12/2010 concerning the Issuing Authority of Certificate of Origin for Indonesia Export Product.
- 2) Referring to your request, kindly find enclosed are the Specimen of Signature and Official Seals of our 86 Regional Issuing Authorities.
- 3) In case of your inquiries, the specimens of signatures on the Indonesia Certificates of Origin (Form B) will include the information of name, address, country, phone and fax number of Our Regional Issuing Authorities. This modified mechanism will be systematically and electronically applied in our certificate of origin electronic system since 13th August 2014.

In case of private institutions, state date of authorization to certify and delegating public authority. In case of public institutions, state what institution it depends on.

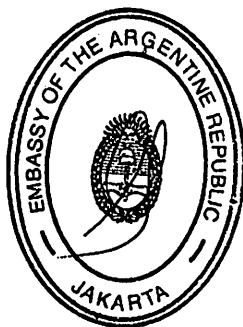
